Have you worked hard to improve quality in your unit, department, or organization? That work should be shared for the benefit of others. Development of professional posters, presentations and manuscripts are necessary to disseminate key findings and implementation strategies from innovative quality improvement projects which have successfully improved the quality and safety of care provided. During this program, attendees will discuss the importance of disseminating findings from quality improvement projects implemented within your hospital and health systems to spread awareness of innovative QI programs. We will discuss how to design eye catching scholarly posters aimed at communicating findings from quality improvement projects findings. Attendees will learn how to design scholarly presentations and manuscripts to clearly communicate their projects findings. SQUIRE Guidelines will be shared as a framework by which to develop your quality improvement manuscript.
